

ORDINANCE NO. 238

AN ORDINANCE AMENDING THE LINN VALLEY, KANSAS CITY CODE TO INCLUDE PENALTIES FOR NON-COMPLIANCE TO CITY ORDINANCES AND CITY CODE.

IT IS HEREBY ORDAINED BY THE GOVERNING BODY OF THE CITY OF LINN VALLEY, KANSAS:

Section 1.

Chapter 4, Article 2, 4-201, Section 108.4 of the Code of the City of Linn Valley is hereby amended to read in its entirety:

Section 108.4 Penalties. Work commencing before permit issuance. Any person who commences any work requiring a permit prior to obtaining the necessary permit shall be required to obtain a permit and be subject to a daily fine of no more than \$100.00 a day, but not less than \$25.00 a day, until such time as the proper permit is obtained.

Section 2.

Chapter 8, Article 1, 8.107 of the Code of the City of Linn Valley is hereby amended to read in its entirety:

8-107. Failure to comply; penalty

Should the person, property owner, corporation, partnership or association fail to comply with the notice to abate the nuisance, the public officer may issue a citation against such person, or property owner requiring appearance of such person or property owner, corporation, partnership, or association in the municipal court of the city against such person, property, property owner corporation, partnership or association and upon conviction of any violation of provisions of section 8-101, be fined in an amount not to exceed \$100.00 a day, but not less than \$25.00 a day, plus court costs, or be imprisoned not to exceed 30 days, or be both fined and imprisoned. The daily fine amount shall accrue from the time of issuance of citation until a conviction by a competent court in Linn Valley, Kansas.

Section 3.

Chapter 8, Article 2, 8.209 of the Code of the City of Linn Valley is hereby amended to read in its entirety:

8-209. Failure to comply; penalty

Should the person or property owner fail to comply with the notice to abate the nuisance the public officer may issue a citation against such person or property owner requiring appearance of such person or property owner in the municipal court of the city against such person upon conviction of any violation of provisions of section 8-203, be fined in an amount not to exceed \$100.00 a day, but not less than \$25.00 a day, plus court costs, or be imprisoned not to exceed 30 days, or be both fined and imprisoned. The daily fine amount shall accrue from the time of issuance of citation until a conviction by a competent court in Linn Valley, Kansas.

Section 4.

Chapter 8, Article 3, 8-301, Section 106.4 of the Code of the City of Linn Valley is hereby amended to read in its entirety:

Section 106.4 is hereby amended to read, in its entirety: Section 106.4 Violation penalties. Any person who shall violate a provision of this code, or fail to comply therewith, or with any of the requirements thereof, shall be fined in an amount not to exceed \$100.00 a day, but not less than \$25.00 a day, plus court costs. The daily fine amount shall accrue from the time of issuance of citation until a conviction by a competent court in Linn Valley, Kansas.
